- Candidates are advised to fill in the entire application form carefully, particularly ensure correct entries of personal particulars, CNIC number, domicile, educational qualification, religion, gender and functional phone number etc.
- Separate online application form shall be used to apply for more than one post and for more than one category of posts.
- T.A/D.A shall not be admissible. **The original documents shall be checked at the time of interview, in case of any discrepancy, the candidature would be liable to be canceled.**
- Candidates in Government Service will have to resign from their service before joining, if they are selected.
- BISP is an equal opportunity employer and encourages all genders and other candidates belonging to marginalized segments of society to apply.
- Female candidates having Valid Motorcycle Driving License may also apply for the posts other than those reserved for female candidates.
- No Age relaxation will be admissible.
