Procurement of Interactive Screens

2. BISP hereby invites quotations from eligible suppliers/vendors duly registered with the Income & Sales Tax Department and are on the Active Taxpayers List (ATL) of FBR for the supply of **“Procurement of Interactive Screens”** as per the following;

3. The complete set of RFQ documents are available on the websites of PPRA (www.ppra.org.pk) & BISP (www.bisp.gov.pk), free of cost. The same can also be obtained from **BISP, Room#236, F-Block, Pak. Secretariat, and Islamabad.**

4. A supplier shall quote for the whole quantity/software, the quotation shall be delivered to the address given below on or before **28th February 2022 at 1100 hours**. Quotations will be opened at **1130 hours on the same day** at the address given below, in the presence of the suppliers or representatives who may choose to attend.

5. The received quotations will be evaluated as per ‘RFQ’/Shopping method of procurement in accordance with the World Bank Guidelines 2011 (revised 2014) and Procurement Regulations, July 2016 available on www.worldbank.org. The acceptable terms and conditions of the lowest, responsive quotation shall be incorporated in the Contract and Purchase Order.

6. The quotation must be valid for at least 90 days from the submission date and the quoted price should include all the applicable local taxes/duties/insurance/transportation/fee/demurrages etc. and must include all other services which are mandatory while purposing the goods, on DDP base with segregation of taxes in columnar form as per RFQ Documents.
